

The Mandatory Travel Advisory For Traveling to UK From Bangladesh (with effect from 04am, on Friday 07 January'2022)

AA) Before travel to UK Fully Vaccinated passengers must follow –

i) Passengers arriving in the United Kingdom, who are fully vaccinated or otherwise meet the eligibility criteria, will no longer be required to provide a Pre-Departure Test (PDT).

ii) Fill up and Submit PLF (Passenger Locator Form) within 48 hrs prior to arrival in the UK. Please see link : (<https://www.gov.uk/provide-journey-contact-details-before-travel-uk>)

- 1. Passengers with the vaccine status “Verified Full/Exempt” or “Declared Full/Exempt” on their Passenger Locator Form (PLF) do not need to provide evidence of a negative PDT(Pre Departure Test).**
- 2. Passengers with the vaccine status “No/Not Declared” must show evidence of a negative PDT(Pre Departure Test).**
- 3. Passengers with the vaccine status “Declared Full/Exempt” must show evidence of their eligibility to be treated as fully vaccinated.**

iii) Book for a Lateral Flow Device (LFD) test as Day 2. No longer to be required to self-isolate until the result of the test taken on or before day 2 is known.

BB) Before travel to UK Non Vaccinated passengers must follow–

- i) Fill up and submit PLF (Passenger Locator Form) within 48 hrs prior to arrival in the UK. Please see link : (<https://www.gov.uk/provide-journey-contact-details-before-travel-uk>)**
- ii) Book and pay for Day 2 & Day 8 PCR (COVID-19) test and self-isolate until receive a negative test result.

- iii) Must to take COVID-19 negative certificate within 48 hours (2days) from the time of departure.

CC) When arrive in England **Fully Vaccinated** passengers are –

- 1) After arrive in England passengers must take a Lateral Flow Device (LFD) test as Day 2. No longer to be required to self-isolate until the result of the test taken on or before day 2 is known.
- 2) Vaccines are allow under recognize- UK Vaccination programme/UK Vaccination programme overseas/an approved Vaccination programme in Europe or the USA.

N.B.

1) **Fully Vaccinated** means the passenger who have received 2nd dose of vaccine minimum 14 days before the travel date.

2) **From 4am on Monday 22 November**, UK govt. will recognize the following vaccines :-
i) **Phizer BioNTech** ii) **Oxford AstraZeneca (including Covishield)** iii) **Modena**, iv) **Janssen** (Johnson and Johnson) and WHO EUL including v) **Sinovac**, vi) **Sinopham Beijing** and vii) **Covaxin**. **Please see link** -(<https://www.gov.uk/guidance/countries-with-approved-covid-19-vaccination-programmes-and-proof-of-vaccination#approved-vaccines>)

3) Fully Vaccinated passengers will be exempt from self-isolate upon arrival, day 8 testing and pre-departure testing. They will just need to book for a lateral flow test to take before the end of their second day, post arrival. **Please see link**-.(<https://www.gov.uk/find-travel-test-provider>)

From 4am on Monday 22 November Travels rules for all under-18s Child – Under18s child those who will be treated as fully vaccinated at the border and will be exempt from self- isolation requirement on arrival, day 8 testing and pre departure testing. They will only be required to take 1 arrival test and a confirmatory free PCR test if they test positive.

DD) When arrive in England are **Not Fully Vaccinated** passengers are –

- 1) **Mandatory quarantine at home or in the place passengers are staying for 10 days**
- 2) **Take COVID-19 PCR test on or before day 2 and on or after day 8.**

The Mandatory Travel Advisory For Traveling From UK to Bangladesh (With effect from 1200 BST, on Saturday 04 Decemember'2021)

Incoming passengers from all destinations including UK aged above 12 years old shall mandatorily possess RT PCR based COVID-19 negative certificate within 48 hours of the flight departure.
