

DAC - SIN:

With effect from **26 October 2021, 1159 hours (Singapore time)**, following fully vaccinated groups with will be **allowed to enter** Singapore in accordance with mentioned prerequisite:

1. Individuals, who have received vaccine & Completed **14 days** from the **first dose of Johnson & Johnson** or the **second dose** of other vaccines recognized by Ministry of Health, Singapore.
2. **Approval Letter of Entry (ALE):**
 - a) Long-Term Pass holders or holders of In-Principal Approval (IPA) letters: with an **approval Letter of Entry (ALE)** issued by the Immigration and Checkpoints Authority (ICA), the Ministry of Manpower (MOM), or the Ministry of Education (MOE), or the Ministry of Trade and Industry (MTI) or a Safe Travel Pass (STP) issued by the Safe Travel Office (STO); and
 - (b) Short-term visitors with ALE issued by ICA or a STP issued by STO.
3. Negative **RT-PCR test certificate** for all (**above 2 years**), from any Bangladesh Govt. Approved Laboratory **within 48 hours validity from sample collection to Departure** for Singapore. This certificate **must state** following details:

- ✓ Test Result,
 - ✓ Date of PCR test,
 - ✓ Pass holder's particulars as indicated on the passport (date of birth, nationality, passport number). If the particulars do not match, then he/she must produce relevant documents for verification.
4. **COVID-19 RT-PCR test upon arrival at Changi Airport (for Short term visitors only): before arrival in Singapore** **Must Register & Pay fees for the covid-19 PCR test upon arrival: (\$160** including GST for PCR test), Using link: <https://safetravel.changiairport.com/#/>.
5. **Mandatory Quarantine/ SHN** from **26 OCT'21** till further notice **at self-cost:** all are required to serve a **10-day SHN at an SHN dedicated facility (SDF) (\$1,450 including GST)** and:
 - Self-administer Antigen Rapid Tests (\$20 including GST) on Days 3 and 7 of arrival; and
 - Take a COVID-19 PCR test (\$125 including GST) on Day 10 of SHN.
6. Download & install **"Trace Together"** apps in your smart phone before departure.
7. **Only for pass holders who were vaccinated Outside Singapore:** Take serology test at a [Public Health Preparedness Clinic](#) to confirm their vaccination status within **14 days of completing SHN**.
8. **Transit Passengers are not allowed via Singapore.**
9. **Singaporean Citizen/PR holders can return to Singapore without any restriction.**
10. Upon arrival at Singapore **NO BODY** can receive them at Changi Airport.

SIN - DAC:

01. All incoming Passengers (**above 12 years**) to BGD shall mandatorily possess **'Polymerase Chain Reaction (PCR)' Covid-19 Test Negative Certificate**, providing that the **test shall be done within 48 hours** from sample collection to flight departure.
02. Undergo a Covid-19 health screening upon arrival in BD.
03. Each Passenger must complete a **'Health Declaration Form'** before arrival to Dhaka.
04. Arriving passengers, who already have vaccinated with 2 doses of COVID-19 vaccine and possesses PCR based COVID-19 negative certificate along with the proof of vaccination, **no quarantine is required**.
05. Arriving passengers carrying PCR based COVID-19 negative certificate and either already have vaccinated with 1st dose (proof of vaccination needs to be carried) or not yet vaccinated, shall have to complete **a mandatory 14 (three) days home quarantine** at government nominated facilities or at hotels on passenger's own expenses.
